Payment Plan - Terms & Conditions NZ Resident students

- 1. The 2024 programme fee for Year 1 and Year 2 students on a payment plan is \$4,950 + GST "Programme fee". The breakdown for this programme fee is: 5692.25
 - a. \$4,495 +GST full fees (including the \$480 +GST deposit)
 - b. \$95 +GST payment plan establishment fee
 - c. \$60 +GST payment plan admin/processing fee x 6 payments received after the final fee deadline
- 2. For students taking up this payment plan, instalments of this fee is due as follows:
 - a. \$480 deposit plus \$95 payment plan establishment fee (total \$575 +GST) plus this signed agreement is due 4 weeks after being offered a place, or 9th December, whichever is earlier.
 - b. **\$1,000 +GST** is due by 16 January 2024
 - c. the remaining \$3,375 +GST is due in 6 instalments of **\$565 +GST** (including \$60+GST admin/processing fee) on or before the following dates:
 - i. 15 February 2024
 - ii. 15 March 2024
 - iii. 15 April 2024
 - iv. 15 May 2024
 - v. 15 June 2024
 - i. 15 July 2024
- 3. All tuition fees must be paid in full by 15 June 2024.
- 4. By opting for the Payment Plan option you:
 - Agree to pay the amounts set out in clause 2 above on the dates set out therein to Dance Therapy Diploma Ltd.
 - You will receive payment reminders of your payment plan via email, along with an invoice against which to make the payment installment either by bank transfer or credit card (through stripe).
 - You are liable for any fees or charges imposed by your bank account provider except to the extent that they are imposed as a result of our error or system failure.
 - All payments are in New Zealand dollars. You are solely liable for any currency conversion fee charged.
 - If any payment is received after the dates set out above, a late fee of \$25 +GST will be
 added to the next payment due to cover the additional administration cost incurred by
 Diploma Dance Therapy.
- 5. Diploma Dance Therapy Ltd does not receive any government funding. Our ability to deliver a training course is dependent on the enrolments and the fees our students pay. We believe in contributing to the growth of Dance Movement Therapy as a profession and do not aim to make a profit from our programmes, as a result we keep our programme fees as low as possible to ensure accessibility for those who wish to study with us. Our programmes require a lot of planning and organising. We need to book venues and commit to paying our teaching and administration team and are unable to reduce our overheads at short notice.
 - a. Should you choose to withdraw from your enrolled Diploma Dance Therapy programme or to defer your participation at any time after the final course

withdrawal date (xxx, 2024), you will remain liable for the total Programme fee outlined in this contract.

- b. If you withdraw after the course commencement date and prior to the final withdrawal date (xxx 2024), the following is non-refundable:
 - i. deposit of \$480 +GST
 - ii. payment plan establishment fee of \$95 +GST
 - iii. 50% of the full course fee (\$2,000 +GST)
 - iv. any payment plan admin fees (\$60 +GST per payment made after the final fee deadline)
 - v. Foundation Module fees and any make up fees
 - vi. If the student has not paid the above in full, any remaining fees due are payable prior to the cancellation of the payment plan/direct debit and withdrawal can be finalized
- c. If you withdraw after the final fee deadline and prior to the course commencement date (xxx 2024), the following is non refundable:
 - i. deposit of \$480 +GST
 - ii. payment plan establishment fee of \$95 +GST
 - iii. 25% of the full course fee (\$1,000 +GST)
 - iv. any payment plan admin fees (\$60+GST per payment made after the final fee deadline)
 - v. Foundation Module fees and any make up fees
 - vi. If you have made any additional payments, these are refundable less the \$60 admin payment plan fee per payment
- d. If you withdraw prior to the final fee deadline (16 January 2024), you will be refunded for any installments you have made prior to that date, except for:
 - i. deposit of \$480 +GST
 - ii. payment plan establishment fee of \$95 +GST
 - iii. Foundation Module fees and any make up fees
